

# Privacy Policy for Bette Forester Monthly Calendar Emails

In this policy I, **Bette Forester, 655 Broadview Ave., Toronto, ON, M4K 2P3, Canada**, inform you about how I collect, use and disclose personal data from and about you, through my Calendar Mailing List, held and executed through MailChimp.

Note, I am an individual, not a company or a corporation of any sort, and most of my users (subscribers) know me personally. Users who subscribe to my Calendar Mailing List expect to receive my monthly Calendar email (plus a few extras each year). I do not use the Calendar Mailing List to solicit any business for myself or others. I do not use my Calendar Mailing List for any business promotion or to sell any merchandise or services.

In the MailChimp context I am the "Member" and you are the "Contact."

	<b>Issue</b>	<b>Information</b>
1.	<b>What and who does this Privacy Policy cover?</b>	<p>I, Bette Forester, collect your name and your email address when you register for my monthly email Calendar. You register this information on a page held and controlled by MailChimp. This data becomes a part of my Calendar Mailing List, held by MailChimp and used by MailChimp for sending my monthly email Calendars. By registering you have consented to my sending you my monthly Calendar emails.</p> <p>This Privacy Policy applies to all users (subscribers) who receive my Calendars.</p>
2.	<b>What kind of personal data do I collect about you?</b>	<p>In particular, through MailChimp I collect only your name and your email address along with your preference to receive email as either HTML or text.</p> <p>I collect no further information from or about you. I collect no financial information or sensitive information, nor is your information linked to any other sites—including social sites.</p>
3.	<b>How do I use your personal data?</b>	<p>The reason I collect this data about you is to provide you with my monthly Calendar by email and occasional unscheduled additional emails relating to a calendar event such as St. Patrick's Day or Pi Day or Luke Skywalker Day.</p>
4.	<b>On what basis do I use your personal data?</b>	<p>I collect your personal data mainly in order to provide you with my monthly Calendar emails, as per your consent by registering.</p>

5.	<b>How do I process your personal data?</b>	The security of your data is a priority for me. I am the only person with access to your data, other than MailChimp. If something happens to me, I will leave instructions for one of my children to delete the Mail Chimp mailing list.
6.	<b>Who can access to your personal data?</b>	I NEVER share. NOT EVER.
7.	<b>Is your personal data transferred abroad?</b>	I never transfer your data from the MailChimp mailing list.
8.	<b>What are your rights with regard to your personal data?</b>	You have a number of rights with regard to your personal data and these include the right to access, complete, update, amend and delete your personal data, as it resides on the MailChimp server. You may access your information through MailChimp. Just hit "update your preferences" near the bottom of every Calendar email. Of course you may always unsubscribe at any time by hitting "unsubscribe."
9.	<b>What is the retention period applying to your personal data?</b>	The personal data I collect is retained for until you request it be removed. You can unsubscribe either through MailChimp (notice at the bottom of each mailing), or contact me directly at <a href="mailto:bette@bette.ca">bette@bette.ca</a> .
10.	<b>Updates to this Privacy Policy</b>	I may modify or update this Privacy Policy at any time in order to comply with applicable law. I will notify you of any changes.  Please look at the Effective Date at the top of this Privacy Policy table to see when this Privacy Policy was last revised.
